

## **Privacy Statement**

#### What information do we collect?

Full House Theatre collects information about the number of participants, their ages, gender and ethnicity as well as verbal and written feedback from both adults and children. For funding purposes (to prove we are reaching the right participants) we will collect addresses including postcodes. You can choose not to give us certain information.

Full House Theatre will collect the names, postal addresses and email addresses of our supporters for such purposes as to send out our e-newsletter (if chosen to receive this) to send out promotional material (both electronic and printed) about our projects and shows.

Full House Theatre collects information about those who visit our website via Google Analytics and Facebook. The information that is collected is anonymous.

### Who is collecting this information and how?

Full House Theatre staff will collect information through printed forms used at one of our shows or during one of our projects. We will enter the information into electronic databases which are stored securely in our company files located on SharePoint within Microsoft Office 365 cloud storage. #### MailChimp

Full House Theatre uses MailChimp to collate the names, postal addresses and email addresses of our subscribers when they sign up to our newsletter via our sign up form on our website. ### Why do we collect this information?

Full House Theatre uses Microsoft Office 365 and Barracuda Software to ensure the information we hold is safe and secure.

Through the Eventbrite platform we are able to issue tickets to shows and workshops as well as communicate with our audiences where necessary e.g. change of venue or show cancellation.

By using MailChimp we are able to send out our e-newsletter to all our wonderful supporters.

We use the information processed by Google Analytics and Facebook to compile reports and to help us improve our website, for example by making sure users are finding what they need easily.

### How will this information be used and / or shared?

We will never sell your data and we promise to keep your details safe and secure.

As a registered charity we are able to deliver our brilliant projects only because we receive vital funding from a variety of trusts and foundations. When working with a funder to deliver a project we will only collect information about project participants which is necessary to the successful running of the project. Some of this information will be personal data such as name, address, age, ethnicity and gender. However we will not share full names, full addresses. Personal data will be made anonymous as much as possible e.g. not providing the names of participants or a full postal addresses only a postcode.

Additionally, our website uses cookies to improve your experience while you're with us, for traffic analytics, and advertising. No personal information is shared or stored. Please see our <u>cookie policy</u> for more information.
